On April 18, 2023, the Town of Cicero hosted a Strategic Visioning at the Cicero Volunteer Fire Department for the Town's Comprehensive Plan & Zoning Code Update project. During the Workshop, the Bergmann consultant team introduced the public to the project and proposed process, provided an overview of the basics of comprehensive planning and zoning, and collected and responded to questions and comments. At the end of the Workshop, a Ideas Wall discussion board, available online via Social Pinpoint, was launched and attendees at the Workshop were invited to participate. Following the Workshop, the Ideas Wall was also advertised on the project website. The Ideas Wall is still open for discussions and has received 62 comments so far.

The purpose of the Ideas Wall was to collect public input on the key strengths, weaknesses, opportunities, and threats that the Town of Cicero faces. Participants were invited write down their thoughts and respond to each other's ideas on a virtual forum. There were six different categories of sticky notes to choose from: Neighborhoods & Residential Development, Parks & Recreation, Transportation & Infrastructure, Waterfront, Governmental Services, and Business & Industrial Development.

An interpretation of the comments on the Ideas Wall is summarized in the following pages, and a full record of the discussions is available in the Appendix.

Neighborhood & Residential Development

Discussion in this topic area focused on efforts to preserve green space and agricultural land. Some participants expressed interest in development regulations to protect the waterfront and environment, while "fixing" unsustainable growth patterns. Overall, participants voiced concern over unchecked development.

There needs to be more requirements for developments. We can't continue to raze all of the remaining wooded areas and turn every farm field into a new home development. Green spaces need to be taken into consideration for the wild life and health of the community.

In this topic area, participants discussed the importance of protecting undeveloped greenspace, creating more walkable trails and paths, and creating more activities and events for Cicero residents to enjoy. One discussion focused on making roads safer for multi-modal transportation, especially walking and biking.

Transportation & Infrastructure

Discussions in the Transportation & Infrastructure largely focused on improving the safety of Route 31, Route 11, Lakeshore Road. Many participants voiced the desire for Cicero to be more walkable and bikeable by improving bike and pedestrian infrastructure. Other discussions revealed a wide variety of opinions:

- Utility lines should be moved underground
- Discussion whether roundabouts would be beneficial or harmful to the community
- Curbing traffic noise
- Development pattern of future roads

This topic received the most comments and replies.

Conversations in this topic area focused on opening access to the waterfront for public enjoyment. A public lake walk with bike access, and a small lakefront museum would attract many people to Cicero. One discussion highlighted the need for marinas and boat launches, without increasing the level of traffic to the area.

This proposal may already be in the works. Having a public lake walk would attract hundreds of people. The walk should not be dependent on patronizing any business, but would be public, with public parking. Having a small, adjacent park, would be icing on the cake.
